CORN: \$5.91 with a volatility factor of 0.18 CORN- Organic: \$11.10 with a volatility factor of 0.18 SOYBEANS: \$13.76 with a volatility factor of 0.13 SOYBEANS- Organic: \$28.29 with a volatility factor of 0.13
